Name	Description
Additional Liability Coverage	Customer may purchase up to \$10,000 in additional liability coverage so long as articles are not prohibited and additional insurance does not exceed the value of the product or \$10 per pound, whichever is less. Carrier reserves the right to deny coverage for any reason. <ul style="list-style-type: none">• 3.5% of declared value, \$25.00 Min, \$300.00 Max, when declared value <= \$10,000.00
After Hours (Mon-Fri)	When service is requested between the hours of 5:30 PM and 7:30 AM, Monday through Friday, the After Hours_Mon-Fri Accessorial Charge will apply. Available in some terminal cities. Pre-Approval from the carrier is required. Freight and other charges also apply. <ul style="list-style-type: none">• \$2.81 per lb, \$141.35 Min, from/to MANITOULIN• \$110.00 (default)
After Hours (Weekend/Holiday)	When service is requested for service on Saturdays, Sundays and holidays. Freight and other charges also apply. Available in some terminal cities. Pre-Approval from the carrier is required. Freight and other charges also apply. <ul style="list-style-type: none">• \$306.20, from/to MANITOULIN• \$185.00 (default)
Airport Pickup or Delivery	Charge assessed for pick up/delivery of freight from/to an airport. <ul style="list-style-type: none">• \$45.00
Bill of Lading Correction	When bill of lading corrections are requested by the authorized party, after the bill of lading is tendered to the carrier. <ul style="list-style-type: none">• \$33.50, from/to MANITOULIN• \$10.50 (default)
Blind Shipment	When a third party controls the movement of the freight but does not want the Consignor or consignee to know the name of the other, the shipment is considered a "Blind Shipment". <ul style="list-style-type: none">• \$57.75
Bond Charges	This applies to shipments moving under United States Customs Bond for U.S. Customs clearance. <ul style="list-style-type: none">• \$0.0581 per lb, \$92.30 Min, from/to MANITOULIN
Border Security Charge	Processing fee will apply on all cross border shipments moving between Canada and the United States <ul style="list-style-type: none">• \$31.50, when weight <= 9,999, from/to MANITOULIN• \$52.25, when weight >= 10,000 lb, from/to MANITOULIN
COD (Cash on Delivery)	Must be paid with check or money order made payable to the shipper. <ul style="list-style-type: none">• 3.5% of COD amount, \$42.00 Min
Credit Card Processing Fee	Charge assessed for each transaction that the carrier is requested to process a payment for a shipment(s) or invoice(s) with a credit card. <ul style="list-style-type: none">• 4% of total charges processed on a credit card transaction

Name	Description
Cross-Dock Fee	When Carrier is asked to unload and/or reload freight. Fee applies only when Carrier is NOT providing either the pick up, delivery, or line haul service. <ul style="list-style-type: none">• <i>\$0.0264 per lb, \$79.60 Min, \$335.85 Max, from/to MANITOULIN</i>• <i>\$0.045 per lb, \$55.00 Min (default)</i>
Debris Removal	When packaging material is removed from a customer site at the request of the customer. <ul style="list-style-type: none">• <i>\$42.00</i>
Delivery on Arrival	A shipment that requires delivery as soon as Carrier receives it. <ul style="list-style-type: none">• <i>\$78.75</i>
Detention (With Power)	When the Carrier is delayed by the Consignor or Consignee for loading or unloading. Detention charges will begin upon the expiration of the applicable free time allowed, and will end when the vehicle is loaded or unloaded and available for movement. \$25.00 for every 15 minutes beyond the first 30 minutes. <ul style="list-style-type: none">• <i>\$26.25 per 15 min after 30 min</i>
Detention (Without Power)	When the Carrier is delayed by the Consignor or Consignee for loading or unloading. Detention charges will begin upon the expiration of the applicable free time allowed, and will end when the vehicle is loaded or unloaded and available for movement. <ul style="list-style-type: none">• <i>\$198.85, from/to MANITOULIN</i>• <i>\$105.00 per day after 1 hr (default)</i>
Extra Labor	Charged when manpower, aside from a pick up or delivery driver (who is performing only pick up or delivery functions) is requested by the Consignor or Consignee to perform service. If the extra labor is required to drive a vehicle to the place of service, the Extra Labor Miles accessorial will also apply. <ul style="list-style-type: none">• <i>\$65.00 per hour, \$65.00 minimum</i>
Extra Labor Miles	Applies when extra labor is required to drive a vehicle to the place of service. Charge does not include labor. Extra Labor shall apply in addition to this charge. <ul style="list-style-type: none">• <i>\$0.065 per mi, \$25.00 Min</i>
Extreme Length - 8'/12'/16'/20'	Charged for each handling units equal to or greater than 8' in length. <ul style="list-style-type: none">• <i>\$173.15, when length >= 10 ft, from/to MANITOULIN</i>• <i>\$68.25, when length between 8 ft and 11.99 ft</i>• <i>\$99.75, when length between 12 ft and 15.99 ft</i>• <i>\$157.50, when length between 16 ft and 19.99 ft</i>• <i>\$252.00, when length >= 20 ft</i>
Food Warehouse Pickup or Delivery	Shipment picked up or delivered to a food warehouse. <ul style="list-style-type: none">• <i>\$0.055 per lb, \$78.75 Min</i>

Name	Description
Glass	Applies to any freight that contains glass, such as windshields, glassware, etc. <ul style="list-style-type: none">• \$6.00
Hazardous Materials	(Hazmat) Materials that pose a risk to the health and safety of the public. Special labeling and handling are required. <ul style="list-style-type: none">• \$43.30, from/to MANITOULIN• \$19.75 (default)
High Cost - Deliver Remote Location	When the carrier is requested to perform a delivery service in a city designated as a High Cost location, a fee will be assessed. See Service Directory for rates
High Cost - Pickup Remote Location	When the carrier is requested to perform a delivery service in a city designated as a High Cost location, a fee will be assessed. See Service Directory for rates
Homeland Security	Charge assessed for shipments destined to be transported via commercial air service. <ul style="list-style-type: none">• \$75.00
Inside Pick-up or Delivery	Shipments that are picked up or delivered to locations other than a dock and require the driver to deliver shipment to a location not immediately adjacent to the delivery vehicle. <ul style="list-style-type: none">• \$0.0581 per lb, \$34.50 Min, \$275.15 Max, from/to MANITOULIN• \$0.0504 per lb, \$47.25 Min, \$500.00 Max (default)
Liftgate	Mechanical equipment used when a customer does not have a dock and the freight cannot be safely loaded or unloaded by the driver alone. <ul style="list-style-type: none">• \$72.55, from/to MANITOULIN• \$0.042 per lb, \$42.00 Min, \$150.00 Max (default)
Limited Access	When pick up or delivery service is requested to a farm, church, school, commercial establishment - not open to the public, construction site, fair, convention center, carnival, prison, or military base. <ul style="list-style-type: none">• \$62.80, from/to MANITOULIN• \$42.00 (default)
Lumper Service Admin Fee	When Carrier hires a third party lumper service for purposes of unloading freight at a consignee location, a lumper service fee will apply. An administration fee that is intended to cover the cost of the labor and the fees associated with coordinating the third party lumper service will also apply. <ul style="list-style-type: none">• \$10.00
Multiple Attempts - Delivery	When freight is unable to be delivered, this charge will be assessed for each attempt. <ul style="list-style-type: none">• \$0.0648 per lb, \$79.60 Min, \$283.90 Max, from/to MANITOULIN• \$0.042 per lb, \$42.00 Min, \$1,500.00 Max (default)

Name	Description
Multiple Attempts - Pick up	When freight is unable to be picked up, this charge will be assessed for each attempt. <ul style="list-style-type: none">• <i>\$0.0588 per lb, \$72.35 Min, \$258.00 Max, from/to MANITOULIN</i>• <i>\$45.00 (default)</i>
New Mexico Gross Receipts Tax	New Mexico Gross Receipts Tax for any shipment shipped within the state of New Mexico <ul style="list-style-type: none">• <i>8% of total freight charge, between NEW MEXICO and NEW MEXICO</i>
Notification / Appointment	Anytime Carrier must call to schedule an appointment for pick-up or delivery. <ul style="list-style-type: none">• <i>\$50.50, from/to MANITOULIN</i>• <i>\$15.75 (default)</i>
Packing Charge	When Consignor or Consignee requests Carrier to package or palletize freight for transportation, the Packaging Accessorial Charge shall apply. Supplies are not included in the charge. <ul style="list-style-type: none">• <i>\$65.00 per hour, \$35.00 minimum</i>
Pallet	When Carrier provides a pallet at the request of the Shipper. <ul style="list-style-type: none">• <i>\$10.00</i>
Pallet Jack	When Carrier is required to provide a pallet jack for movement of shipment. <ul style="list-style-type: none">• <i>\$15.00</i>
Photos taken per customer request	When a customer requests photographs to be taken for a shipment when photographs would not typically be required. This charge does not apply to any photographs taken as part of a standard carrier policy or procedure. Service is available in select terminal cities only. Charges are assessed at the carrier's discretion. <ul style="list-style-type: none">• <i>\$20.00</i>
Reconsignment	When a shipment is redirected after tender to Carrier. <ul style="list-style-type: none">• <i>\$79.60, from/to MANITOULIN</i>• <i>\$42.00 (default)</i>
Residential Service	When pick up or delivery service is requested to a place of residence. <ul style="list-style-type: none">• <i>\$72.55, from/to MANITOULIN</i>• <i>\$0.042 per lb, \$42.00 Min (default)</i>
Rural	When pick up or delivery service is requested to be performed more than (5) five, one-way miles from the nearest highway on the Carrier's normal line of travel or municipality served by the Carrier as a direct service point, a Rural Delivery Accessorial Charge will be added and is based on the total number of off-route, round trip miles incurred. <ul style="list-style-type: none">• <i>\$69.15, from/to MANITOULIN</i>• <i>\$2.50 per mi, \$45.00 Min (default)</i>

Name	Description
Sort and Segregation	Applied when the Carrier is requested to sort and segregate a shipment based on the marks, tags, labels, or stencils on any package or piece of freight. <ul style="list-style-type: none">• <i>\$0.0307 per lb, \$98.60 Min, from/to MANITOULIN</i>• <i>\$0.05 per lb, \$45.00 Min (default)</i>
Storage	When through no fault of the Carrier, freight is held in the Carrier's possession by reason, act, or omission of the Consignor or Consignee. Charges shall be applied 48 hours after Consignor notification. The notification waiting period shall not including Saturday, Sunday, or Business holidays. <ul style="list-style-type: none">• <i>\$0.013 per lb, \$37.05 Min, from/to MANITOULIN</i>• <i>Daily \$15.00 per pallet (default)</i>
Time Specific	If pick up or delivery service is requested during a specific time window between the hours of 7:30am and 5:30pm Monday through Friday. <ul style="list-style-type: none">• <i>\$85.00</i>
Unpack	When a driver is asked to remove freight from its packaging, the Unpack Accessorial Charge will apply. Charge does not include removal of debris. <ul style="list-style-type: none">• <i>\$65.00 per hr, \$35.00 Min</i>
Weight/Class Inspection Fee	Applies to any freight with misstated Weight, inaccurate Class, or NMFC item on Inspection. <ul style="list-style-type: none">• <i>\$18.15, from/to MANITOULIN</i>• <i>\$5.25 (default)</i>
